Meeting Minutes for January 12, 2024

1. Call to order. Robert Ronzio calls the meeting to order at 11:30 AM.

2. **Disposal System Construction Permits**

1. **73 Porcupine Court-** DSCP & LUA -Soils analysis report. Mr. Kulig states the existing septic system failed a Title 5 inspection. Mr. Kulig states the existing single family home is on a modest size lot, with the well located by the road. Mr. Kulig states they conducted a sieve analysis and the soils are challenging. Mr. Kulig points out the design is an Eljen system, the water table is high and there are site constraints. Mr. Ronzio asks if the new system is being installed in the same location as the existing system. Mr. Kulig states the new system will be located at the rear left side of the property from the road, to avoid the contaminated soils of the existing system. Mr. Kulig states they are outside of the well setback requirements, and the 2 foot separation from groundwater are allowed with the Eljen system design. Mr. Kulig states for a modest property this is a pricey option. Ms. LaBelle makes a motion to approve the plan with a 2 foot separation from groundwater. Mr. Ronzio seconds the motion. Ms. LaBelle votes in favor. Mr. Ronzio votes in favor. **Motion passes.**

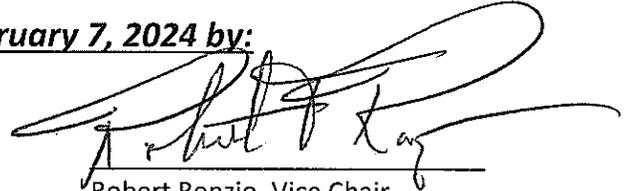
