New Business: Ms. Hoecker brings up changes that they would like to make to the Zoning By-laws
Table of Contents $\S 3.1 .1$ and 3.1.3, Use Regulations and Residential. §3.4.4 and 3.4.5 Non-Conforming One- and Two-Family Dwellings. Ms. Hoecker would like to change $Y$ to read Permitted as of right with Building Inspector approval in all cases. Add in all cases to Prohibited in N. Eliminate Special Permit/Planning Board and add Planning Board Special Permit in all cases to PB. E liminate some of the symbols used (ZBA, SB and SPR) and add a new symbol U- Use permitted as of right with Zoning Board of Appeals Site Plan Review approval in all cases. Chairman Ronzio would like to know the reasoning behind the changes. Ms. Hoecker says it is to create clarity and better understanding for the public. Chairman Ronzio says the only one he agrees with is eliminating SB Special Permit/Board of Selectmen. Chairman Ronzio feels the changes are more confusing and not necessary. Going on to §3.4.4 and 3.4.5
The first change is just grammatical. Chairman Ronzio explains that this is the first time the board has meet and discussed this issue and that they can't agree with these changes without further discussion. Chairman Ronzio tells the ZBA to write up the changes and get it to the Planning Board and we will need to have a Public Hearing on the issue. Ms. Hoecker said she would work on that and would work on the dates for the Public Hearing.
